Agenda 128: Matters arising from the minutes

Maesgarmon streetlight CS15: Cllr DJ informed the meeting that as part of the recent PCC budget settlement no action will be taken on any streetlights for the next year. Cllr DJ told the meeting he would try his best to reverse this decision later in the year but was not hopeful. 2. Flooding in Cyfronydd by the river bridge, Andrew Jones from North and Mid Wales Trunk Road Agency has been on annual leave, Cllr NB will make contact and take forward. Cllr GD requested we record the timescale taken is 12 months to date. 3. Leylandii trees overhanging in playground, Jack Tavernor has agreed to undertake the works. Clerk will ask for timescale, as pending playground works will be affected by inaction with trees. 4. 87 bus to Welshpool: No response received from Cllr Davies following our request for information about the follow on route of the 87 bus from Llanfair at 3.30pm, Clerk will contact Cllr Davies again. New bus timetable on display. 5. One of the blind spot bushes opposite the playground in Maesgarmon has been removed; we anticipate the second bush will be removed by the end of the month.

Agenda 134: Attendance at meetings

1. Cllr NE reported on recreation committee meeting: The committee are organising a family day on 7th July starting at 11am, all are very welcome to attend, there will be a village walk followed by a picnic and games. New gym area in the community centre is moving forward, in the process of looking at key-card system and keeping a separate access point. Refurbishment of the area will be required and the committee are looking at grants to help with costs.
2. Cllr CJ and Cllr NE attended rights of way training day in Newtown which they found very informative, and will support the sub committee with their plans for circular walks within the village.
3. The sub-committee met with CPRW to go through the proposed first circular walk, CPRW have advised we contact PCC (Calum Carr) for advice on support available and how best to proceed in terms of contacting the appropriate parties.

Agenda 135: Any other business

1. The final recommendations report of the review of electoral arrangements was discussed and the proposal to change Castle Caereinion from the Guisfield ward to Berriew. To be called Berriew and Castle Caereinion, welsh language name of Aberriw a Chastell Caereinion. Cllrs are unhappy with welsh spelling and have asked the Clerk to write to the Minister for Housing and Local Government (as directed within the recommendations report) to strongly object. Cllrs requested Clerk make it known that Castle Caereinion is known as Castell Caereinion in Welsh, and furthermore they would prefer to remain with Guisfield.
2. Cllr CJ asked if a notice could be put up to promote the new garden waste scheme with PCC, clerk will ask PCC for a marketing poster.
3. Cllr GH asked Clerk to contact PCC to request the bin be reinstated at Maesgarmon.
4. Cllr GH reported hand-rail repairs are required on Cwm Lane.
5. New headmaster of Castle Caereinion School, Mr Philip Jones will attend next meeting at 7.30pm.
6. Cllr MJ formally submitted her resignation from the community council from end of April 2019, Cllr NB informed the meeting it was with a great deal of reluctance that he was accepting the resignation and thanked Cllr MJ for all her hard work and commitment over the years and told her she would be very much missed by the committee.
